What is the All About Me Portfolio (K-7)?

All About Me is a student-friendly, interactive portfolio tool that allows K-7 students to reflect on their learning, showcase their growth, and share their achievements. They can easily navigate through the portfolio to explore occupations, write journal entries, set goals, and upload files, pictures, videos, drawings, and audio recordings.

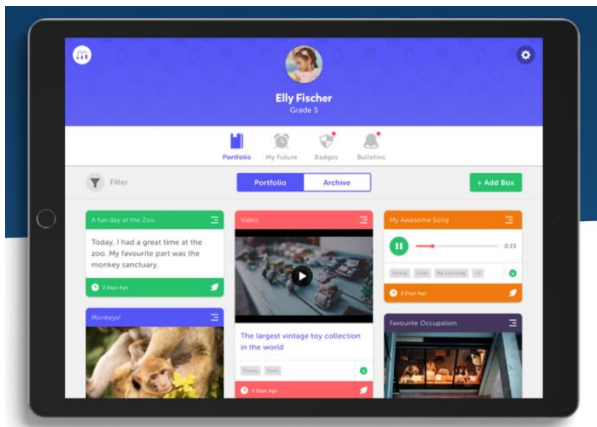
As a parent/guardian, can I access All About Me?

Yes! All About Me can be accessed by the student's family. Your child's teacher can send an account invitation to your email to get you set up with your account.

Why would I want access to All About Me?

The brand-new family account will allow you to view student artifacts and reflections, including the goals they are setting, occupations they are interested in, and what they are learning in school. You can also log into your account to comment directly on your child's work!

How does my child login to All About Me?



1. Visit www.myBlueprint.ca/vsb
2. Click **School Account Log-in** (the green button)
3. The student will need their district log-in information from their teacher (same as for Office 365):
 - a. Enter username: **[studentnumber]@learn.vsb.bc.ca**
 - b. Enter their unique password
4. OR use the **QR Login** (generated by a teacher)

Dear Parent/Guardian,

The Vancouver School District is implementing an online educational resource called myBlueprint (www.myBlueprint.ca). This personalized digital portfolio and career/life planning tool is used by thousands of schools across Canada to support communicating student learning which engages our families in ways that better align with emerging self-service trends to provide real-time student progress, reporting, parent participation and student support for our families today.

We believe that myBlueprint allows for more effective, timely and meaningful communication with parents. Evidence of learning may take the form of informal notes, pictures, links to video or audio and student self-assessments/reflections and informs you about your child's progress in relation to the learning standards in BC's redesigned curriculum.

During this school year, students will be active participants and take ownership of their learning by capturing evidence of their learning in collaboration with teachers. Students self-assessment and reflections on their learning will be an integral part of their digital portfolios. Most important, is that you, as parents, will receive information in a timely manner so you can celebrate your child's learning strengths, areas of growth and communicate ways to support with your child's teacher when it is most needed.

As an online service located in Canada, myBlueprint is bound by both federal and provincial Privacy Laws. Accounts are created for all students using a data extracted from the District Student Information System. This allows students to easily log in. As part of the extract, the Vancouver School District will securely provide limited personal information such as Student Number, Name, and School.

Accounts are password protected and only you, your child, your child's teacher(s), and anyone else you grant access to can view the portfolio. Since learning is a social activity and images/videos may display your child learning with others, consideration should be taken to not post or share on social media any content within your child's myBlueprint portfolio that may contain the name and/or likeness of other students in the class.

For teachers to document student learning electronically, your consent is required.

By signing this Agreement, I on my own behalf or, as applicable, on behalf of my child, understand and agree that:

- The Vancouver School District may provide information about my child. This consent is for participating in the myBlueprint initiative;
- All personal information disclosed to myBlueprint will be encrypted and stored on servers located in Canada and managed by service providers engaged by Vancouver School District;
- Student personal information on myBlueprint will be accessible to the student's teachers and school-based administrator, parents;
- Student content on myBlueprint will be accessible by students and parents using web-based applications from locations outside of the School, if I or my child choose to access this material;
- Since learning is a social activity and images/videos may display your child learning with others, consideration should be taken to not post or share on social media any content within my child's myBlueprint portfolio that may contain the name and/or likeness of other students in the class.

I have read this consent form and understand that my child's personal information may be collected, used and disclosed for educational purposes as outlined in the myBlueprint Privacy Policy and Terms of Service. This consent will be considered valid from the date it is signed until which point the student named below is no longer a student with the Vancouver School District, or permission has been withdrawn.
